INTRODUCTION

British Columbia Recognized Academy (BCRA)

The British Columbia Recognized Academy (BCRA) program is designed for private academies within British Columbia. Academies interested in the BCRA program must apply for the designation in accordance with this document, demonstrating an ability to meet technical and administrative standards set by BC Soccer Academies Association.

British Columbia Academy Super League (BCASL)

The British Columbia Academy Soccer League (BCASL) is a board-approved strategic initiative providing outdoor league play to private Academies with BCRA status.

BCRA Applications

Private Academies attaining BCRA status for 2018 are eligible to play in the British Columbia Academy Super League (BCASL), Existing BCRA organizations renewing for 2018 will have the choice of playing in the BCASL will full entitlements under BC Soccer Academies Association.

SUBMISSION PROTOCOL & DEADLINE

(New Applicants)

I. Private Academies

• Private Academies are for-profit soccer organizations comprised of fulltime players and teams.

• The BCRA Request for Proposal (RFP) is open to any private academy registered as a business in British Columbia, whose staff and players are based out of British Columbia, and whose overall business operates out of British Columbia including its headquarters, office, and training facilities. BCRA RFP submissions will not be accepted from BC Soccer affiliated Clubs, Club Academies, and Private Academies not meeting the criteria outlined above.

II. Proposal Submission

• The RFP process will be operated by BC Soccer Academies Association and/or designates thereof.

III. Proposal Deadline

• All RFP submissions must be submitted:

• The deadline for all proposals is 3 weeks prior to the start of each season. Late Proposals will not be considered.

RFPs submitted must include the BCRA Application Form. Proposals must also include all required information outlined in this document. BC Soccer Academies Association reserves the right to reject any or all proposals that are assessed to be incomplete.

BCRA ENTITLEMENTS

BCRA Academies playing in the BCASL

- Full entitlements with BC Soccer Academies Association, including but not limited to:
 - Can participate against Academies in all BCSAA Tournaments, Showcases, Festivals, Exhibition Games, and Futsal Leagues
 - Eligible for BCASL League Cup
 - Access to BCSAA Match Officials
 - BCSAA game insurance coverage
 - Freedom to use the BCASL brand for marketing

• Upon acceptance and approval into the BCRA program, the Academy will be required to sign an ASL Agreement (if applicable).
